PRODUCT DESCRIPTION

- Glass Design vessels are made from silicone, stainless steel, or cut crystal (depending on model)
- Intended use is a vessel placed on a vanity top or furniture for hygiene and personal cleaning purposes.
- Sizes vary depending on model.
- Colours vary by range.
- Designed to be used with stand-along tall basin mixers or wall mounted mixer tapware or mixers.

SCOPE OF USE

- Glass Design Vessels are designed for domestic and light commercial applications.
- Designed to have water supplied via an independent tall basin mixer or wall mounted basin mixer.
- Care must be taken with chemicals and abrasives that may cause damage to the finish of the product.
- Care must be taken to not expose basin to impact damage.
- All plumbing must be installed by a registered plumber and in accordance with AS/NZS3500 Plumbing Regulations.

CONDITIONS OF USE

- Glass Design vessels must be installed by a registered plumber in accordance with the installation instructions provided with the product to AS/NZS3500 plumbing regulations.
- Cleaning and maintenance shall be done in accordance with the manufacturer's warranty/cleaning instructions.
- The pH of water in certain geographical locations can affect the appearance of product over time.
