- Wastes & traps form part of a system to AS/NZS3500 plumbing regulations to prevent foul smells entering a dwelling.
- Must be installed by a registered plumber and in accordance with AS/NZS3500 Plumbing Regulations.

- Shower trap must be installed by a registered plumber in accordance with the installation instructions provided with the product and to AS/NZS3500 plumbing regulations.
- Cleaning and maintenance shall be done in accordance with the manufacturer's warranty/cleaning instructions.
