## **PRODUCT DESCRIPTION**

- Cristina brass slide showers, wall-mounted or ceiling-mounted rain showers, or handshowers are designed to provide showering within a bathroom.
- Finish is chrome plated brass, or PVD coated brass.
- Designed for mains pressure only.
- Slide showers and handshowers are a combination of material including leadfree brass and ABS plastic.
- Wall/Ceiling mounted showers are manufactured from leadfree brass.
- Supplies hot and cold water for showering.
- WELS rated for water efficiency in accordance to AS/NZS6400.

## **SCOPE OF USE**

- Cristina showers are designed for domestic and commercial applications.
- Cristina showers are suitable for mains pressure applications only.
- Care must be taken with chemicals and abrasives that may cause damage to the finish of the product.
- Must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

## **CONDITIONS OF USE**

- Cristina showers must be installed by a registered plumber in accordance with the installation instructions provided with the product and to AS/NZS3500.2:2021 plumbing regulations.
- As per AS/NZS3500.2:2021 Plumbing Regulations "Inline filters and PLV (Pressure Limiting Valves) should be installed
  at each premises to protect the life of valves and cartridges."
- Cleaning and maintenance shall be done in accordance with the manufacturer's warranty/cleaning instructions.
- The PH level of the water within certain geographical locations or water source types can affect the performance or appearance of product.

## **CONTRIBUTIONS TO COMPLIANCE**

- B2.3.1 (a) (ii) and (iii): Cristina brass slide showers, handshowers and rain showers have a durability of at least 10 years when not exposed to harsh abrasives or cleaning chemicals.
- F2.3.1: Cristina showers are safe to handle when installed as per the supplied installation instructions. There are no requirements for this product to comply with Acceptable Solution F2/AS1, First Edition Amendment 3, 2017.
- G1/AS1: Cristina showers are required to be connected to a potable drinking water system and hot water reticulation system as per AS/NZS3500.2:2021 Plumbing Standards and should be installed in accordance with the manufacturers Installation instructions and by a registered plumber.
- G12/AS1: Water supply to showers should be provided in accordance to AS/NZS3500.2:2021 in relation to ensuring the supply does not cause backflow or contamination into the potable water system. All work should be carried out by a registered plumber. Product is manufactured to AS3781 (Tapware Standard). Complies to WELS AS/NZS6400 for water efficiency.
- H1.3.3: Hot water pipes supplying water to mixers should be properly lagged in accordance with AS/NZS3500.2:2021.
   As per AS/NZS3500.2:2021 all shower systems should be protected by (TLV) temperature limiting valves, set to a max temp of 55deg.
