PRODUCT DESCRIPTION

- Silfra Pop up wastes are manufactured from Brass with either chrome, black powder-coat, or PVD finishes (depending on model).
- 32mm or 40mm with or without overflow (depending on model).
- Designed to fit in basins and baths to allow traps to be fitted to comply with AS/NZS3500.2:2021 plumbing regulations.
- Size of dome (top) varies by model see specification for details.

SCOPE OF USE

- Silfra Pop Up Wastes are designed for domestic and light commercial applications.
- Care must be taken with chemicals and abrasives that may cause damage to the finish of the product. See Warranty & installation instructions.
- Wastes form part of a system within AS/NZS3500.2:2021 plumbing regulations to prevent foul smells entering a dwelling.
- Must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

CONDITIONS OF USE

- Silfra Pop Up Wastes must be installed by a registered plumber in accordance with the installation instructions provided with the product and to AS/NZS3500.2:2021 plumbing regulations.
- Cleaning and maintenance shall be done in accordance with the manufacturer's Warranty/Cleaning instructions.
