### PRODUCT DESCRIPTION

- Duravit Vessels are made from Vitreous China or Solid Surface.
- Intended use is a vessel placed on a vanity top or furniture, or wall hung, for hygiene and personal cleaning purposes. Selected models can be undermounted to the vanity top.
- Sizes vary depending on model.
- Colours vary by range.
- Designed to be used with Top mounted mixer tapware or Wall mounted mixers – depending on model.
- D Code Basin 705.45 and 707.45, Architec Basin 766.35, 766.35LH & 766.35RH, and Starck 3 Basin 301.55 are suitable for installation in facilities for people with disabilities.

### SCOPE OF USE

- Duravit Basins and Vessels are designed for domestic and commercial applications.
- Check Spec Sheet to determine which models are suitable for wall mounting, top mounting on a vanity or furniture, freestanding, or undermounted.
- Designed to have water supplied via a top mounted basin mixer or wall mounted basin mixer.
- Care must be taken with chemicals and abrasives that may cause damage to the finish of the product.
- All plumbing must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

### CONDITIONS OF USE

- Duravit Baths must be installed by a registered trade person and as per the manufacturer's instructions.
- All plumbing to and from the bath must be carried out by a registered plumber and in accordance to AS/NZS3500.2:2021.
- These products are intended for domestic or commercial use.
- Not suitable for accessibility facilities.
- Care should be taken when filling the bath with Hot water (Mixture of Hot/Cold ) as per installation instructions.
- Uncontrollable heat source (ie Wet Back systems) are not recommended as water temp above 60deg direct onto the bath surface can cause damage and discolouration.
- Recommended TCV valves with fixed temperature of 55deg recommended as per AS/NZS3500.2:2021 Plumbing Regulations.
- Cleaning shall be done in accordance with the manufacturers cleaning instructions.
- Solvent based cleaners should not be used on any part of the acrylic surface.
