### PRODUCT DESCRIPTION

- Duravit Solid Surface baths are either floorstanding, back to wall, corner or drop in style.
- Duravit DuraSolid/DuroCast baths are made from cast minerals, using 100% recyclable materials. The baths have a velvety matte finish and its surface structure are classed with maximum slip resistance (Class C, the highest class for materials without a coating – Europe) without requiring any additional coating.
- Some baths are supplied with built in overflow, depending on the model.
- Colour is matt white.
- Water working capacity (Volume) refer to TSS (Technical Specification Sheet) per model.

### SCOPE OF USE

- Solid surface Baths are designed for domestic bathing/cleaning applications.
- Designed to be filled by a Bath Filler (floor mounted) or Wall mounted bath mixer.
- Model determines if Floor standing back to wall, Corner or drop in installation.

### CONDITIONS OF USE

- Duravit Baths must be installed by a registered trade person and as per the manufacturer's instructions.
- All plumbing to and from the bath must be carried out by a registered plumber and in accordance to AS/NZS3500.2:2021.
- These products are intended for domestic or commercial use.
- Not suitable for accessibility facilities.
- Care should be taken when filling the bath with Hot water (mixture of hot/cold ) as per installation instructions.
- Uncontrollable heat source (ie wet back systems) are not recommended as water temp above 60deg direct onto the bath surface can cause damage and discolouration.
- TCV valves with a fixed temperature of 55deg are recommended as per AS/NZS3500.2:2021 Plumbing Regulations.
- Cleaning shall be done in accordance with the manufacturer's cleaning instructions.
- Solvent based cleaners should not be used on any surface.

### **CONTRIBUTIONS TO COMPLIANCE**

- B2.3.1 (a) (ii) and (iii) Duravit DuraSolid/DuroCast have a durability of at least 10 years when not exposed to direct UV light and where not crushed or knocked in a way that may cause a crack in the bath, that may cause a leak.
- F2.3.1: Duravit baths are safe when handle when installed as per the supplied installation instructions. There are no requirements for this product to comply with Acceptable Solution F2/AS1, First Edition Amendment 3, 2017.
- G1/AS1: Baths are required to be connected to a waste system to assist the removal of the water as per AS/NZS3500.2:2021 Plumbing Standards and should be installed in accordance with the manufacturer's installation instructions.
- G12/AS1: Water supply to the bath should be provided in accordance to AS/NZS3500.2:2021 to ensure the supply does not cause backflow or contamination into the potable water system.
