PRODUCT DESCRIPTION

- Kaldewei steel enamel baths are either freestanding, back to wall, or drop in style.
- Kaldewei baths are made from made from steel enamel (a combination of robust steel with resilient glass to create an inseparable bond).
- Some models are supplied with built in overflow, depending on the model.
- Colours vary by range, with a wide selection available on request.
- Water working capacity (volume) varies by model, refer to Technical Specification Sheet for detail by model.

SCOPE OF USE

- Kaldewei steel enamel baths are designed for domestic or commercial bathing/cleaning applications.
- Designed to be filled by a Bath Filler (floor mounted) or Wall mounted bath mixer. Some models are fitted with a filler as part of the waste/overflow system.
- Model determines if freestanding, back to wall, or drop in installation.
- Product is robust, is highly resistant to mechanical stress, burning or smoldering objects do not leave marks on the surface, is UV resistant, and common household detergents, cosmetics or bath additives will not harm the Kaldewei steel enamel.
- All plumbing must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

CONDITIONS OF USE

- Kaldewei baths must be installed by a registered trade person and as per the manufacturer's instructions.
- All plumbing to and from the bath must be carried out by a registered plumber and in accordance with AS/NZS3500.2:2021.
- These products are intended for domestic or commercial use.
- Not suitable for accessibility facilities.
- Cleaning shall be done in accordance with the manufacturer's cleaning instructions.

- G1/AS1 Kaldewei baths are required to be connected to a waste system to assist the removal of the water as per AS/NZS3500.2:2021 Plumbing Standards and installed in accordance with the manufacturer's installation instructions.
- G12/AS1 Water supply to the bath should be provided in accordance to AS/NZS3500.2:2021 to ensure the supply
 does not cause backflow or contamination into the potable water system and should be installed by a registered
 plumber.
