PRODUCT DESCRIPTION

- Marblo Vessels are made from Solid Surface material (polymer-based hybrid solid surface)
- Intended use is a vessel placed on a vanity top or furniture, or freestanding/floor-mounted basin, for hygiene and personal cleaning purposes.
- Sizes vary depending on model.
- Colours is matt white.
- Designed to be used with extended height mixers, freestanding/floor-mounted mixer, or wall mounted mixer depending on model.

SCOPE OF USE

- Marblo basins and vessels are designed for domestic and commercial applications.
- Check Spec Sheet to determine which models are suitable for bench-top mounting on a vanity or furniture, or freestanding.
- Designed to have water supplied via an extended basin/sink mixer, wall mounted basin mixer or freestanding/floor mounted mixer (depending on style of basin).
- Care must be taken with chemicals and abrasives that may cause damage to the finish of the product.
- All plumbing must be installed by a registered plumber and in accordance with AS/NZS3500.2:2021 Plumbing Regulations.

CONDITIONS OF USE

- Marblo basins and vessels must be installed by a registered plumber in accordance with the installation instructions
 provided with the product to AS/NZS3500.2:2021 plumbing regulations.
- Cleaning and maintenance shall be done in accordance with the manufacturer's warranty/cleaning instructions.
- Certain areas PH water can affect the performance or appearance of product.
